Delta

From Jangelicas foundation we propose the Delta project under a humanitarian approach to face the migratory crisis that the country of Venezuela is facing in the municipalities of Maicao, department of La Guajira and Cúcuta, department of Norte de Santander of the Republic of Colombia. With special emphasis on caring for mothers who are heads of families and families in the company of children and adolescents.

Justification

As a result of the political crisis in Venezuela, many of its inhabitants were forced to leave their country to seek new opportunities, stability and more dignified living conditions. This leads to mothers and families leaving the country in the company of their children thinking about a future for them. This situation has resulted in irregular migration and in many cases in inhumane conditions.

The phenomenon of migration turns out to be very complex on the Colombian-Venezuelan border, because some migrants pass through Colombia to reach other destination countries, others go to buy merchandise to return to sell it to their country and others seek to Colombia as a place to reside, work and / or study.

To size this phenomenon, it is necessary to take into account the following data:

"The United Nations Interagency Coordination Platform (R4V) reported that the number of Venezuelan migrants in the world currently stands at 5,914,519. (...) They specified that of this figure, some 4,868,246 nationals are living in Latin American and Caribbean countries. (...) Colombia continues to be the country with the highest number of Venezuelans with 1,742,927, Peru follows with 1,286,464, Ecuador with 482,897, Chile with 448,138, among others, according to the instance" (Taken from: Cifra de migrantes venezolanos se acerca a los 6 millones según Plataforma R4V de la ONU - Descifrado

As evidenced in the previous data, the migration crisis is evident and Colombia is positioned as the main host country for Venezuelan migrants, it is worth clarifying that

the estimated number of migrants may be higher, since part of the migration occurs irregularly.

Problematic

Excessive migration of mother's head of families and families in the company of children and adolescents.

Proposal of intervention to the problem

It is intended to create Centers for Immediate Attention to Basic Needs: health, shelter, food and logistical support that allows to meet basic needs of migrant mothers, heads of families and families in the company of children and adolescents, who specifically cross the border from Venezuela to Colombia in the municipality of Maicao, department of La Guajira and in the municipality of Cúcuta, department of Norte de Santander of the Republic of Colombia, so that they can reach their destinations in a dignified manner.

For this we propose the intervention in four factors:

Personal grooming kit

Health Non-prescription drugs

First aid box

Clothing

Refuge Blankets

Sleeping tents

Feeding Food

Hydration

Logistic Support Helps to continue with the routes to the destination.

In order to carry out this project we require:

Grooming kit, clothes, basic medicines, mats, blankets, tents, raincoats, hydration, diapers, vitamins and baby bottles.
